If the Hirer is in any doubt the meaning of the following, A representative from Make it perfect softplay & bouncy castles should be immediately consulted.

THE HIRER:- will during this period of the hiring , be responsible of the equipment, its care, safety from damage, however slight of any sort and the behaviour of all persons of all ages using the equipment whatever their capacity, including proper supervision of children, to ensure children under school age use the equipment separately to older children or adults.

MAXIMUM AGE allowed to use the equipment is years and under . FAILURE to observe this limit at any time during the hire period will render the hirer liable for damages and repair costs occurred.

THE HIRER shall not use the equipment for any other purpose other than described in the Hiring agreement and shall not sub let or use the equipment or allow the equipment to be used for any unlawful purpose or in any unlawful way, nor allow anyone onto the equipment wearing shoes, spectacles, carrying sharp objects, lollipops in mouths, key rings, metal studded clothing, or any similar items which could cause damage to others or the equipment.

NO FOOD OR DRINK IS TO BE TAKE ON OR CONSUMED ON THE EQUIPMENT

NO party poppers, streamers, silly string, to be taken on dressed or thrown onto the equipment, No persons whom have had face paint applied are allowed onto the equipment or any product that leaves a permanent stain/damage .as all leaves permanent stains to the materials and are unremoveable leaving the hirer liable for damages and is to compensate Make it perfect softplay & Bouncy castles in this event of damage in full.

The HIRER shall be deemed to have inspected the equipment (accessories if supplied)

and have agreed that it is supplied in good condition. unless he/she brings this to our attention of representative Make it perfect softplay & bouncy castles when it is set up and checked by the hirer when coming into the possession of the equipment any faults noted by the hirer.

The Hire period unless otherwise agreed, is from delivery 8am -10am and collections between 5pm-7pm. unless agreed with the make it perfect softplay & bouncy castle representative, any obstruction by the hirer or thier guests causing unnecessary delay will be charged £50 per hour or part of, this also applies where Ball pit balls are not bagged and ready for collection.

PUBLIC LIABILITY INSURANCE is excluded in its entirety following any claim or injury to any third party or employee whether directly or indirectly related to the use of drugs and/or alcohol. Make it perfect

softplay&bouncycastleles excludes any liability for injury loss or damage caused by any person or persons using the equipment contrary to the terms and conditions of this contract, **IMPORTANT NOTICE** provided that the equipment is used in accordance with the above guidelines and conditions of hire, those using the inflatable/ equipment should do so safely. Howeve accidents can happen and make it perfect softplay & bouncycastleles can accept NO LIABILITY for injuries sustained or any other loss , however caused.in the absence of negligence of make it perfect soft play & Bouncy Castles or its employees. As the equipment willbe in the hirers posession and control whilst in use rather than Make it perfect softplay & Bouncy castles any liability for injuries or other losses caused other than in the circumstances described above rests with the hirer. Accordingly, it is strongly recommended that the hirer has adequate publicliability insurance covering his or her liability arising from the use of the infaltable/equipment.
